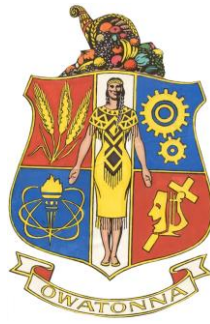

RE: Adoption of S-5 Supplement to the 2015 Ordinance Code

Purpose:

Council approval of Proposed Ordinance 21-3 to adopt the S-5 Supplement to the 2015 Ordinance Code of the City of Owatonna.

Background:

On April 6, 2021, Council approved the first reading of this propose ordinance; there have been no changes since. Annually, American Legal Publishing Corporation, prepares a supplement to our Code of Ordinances which includes ordinances approved since the previous supplement. This is fifth supplement, S-5 and contains 10 ordinances, #1603-1612. American Legal administers the City’s Code on the City’s website which will now include these 10 ordinances. When ordinances are approved, they are available on the city’s website page, “City Code Updates” until they are included in the next supplement.

The Official Copy of the 2015 Code is kept on file in the office of the City Administrator. Copies of the City Code of Ordinances is also provided to the Steele County Court Administrator for the Steele County Law Library located at the Steele County Courthouse and the Owatonna Public Library. An on-line version of the Code is available on the City’s website which enables the public to search, browse, and navigate the City Code.

ORDINANCE NO. ____

AN ORDINANCE ENACTING AND ADOPTING A SUPPLEMENT
TO THE CODE OF ORDINANCES FOR THE CITY OF OWATONNA

WHEREAS American Legal Publishing Corporation of Cincinnati, Ohio, has completed the S-5 Supplement to the 2015 Code of Ordinances of the City of Owatonna, which contains all ordinances of a general and permanent nature enacted since the S-4 Supplement to the 2015 Code of Ordinances of the City of Owatonna.

NOW THEREFORE by the City Council of the City of Owatonna, Minnesota, be it ordained:
