

ORDINANCE NO. 1543

AN ORDINANCE AMENDING ORDINANCE NO. 157 OF THE OWATONNA ZONING ORDINANCE RELATING TO BREWPUBS & TAPROOMS

THE CITY COUNCIL OF THE CITY OF OWATONNA, MINNESOTA, DO ORDAIN:

Section 1. Ordinance No. 157 of the Owatonna Zoning Ordinance is hereby amended by amending Section 157.002 (B) thereof, to read as follows with strikethroughs being deleted and underlines being additions:

BREWER. A person who manufactures malt liquor for sale.

BREWERY. A facility that manufactures malt liquor for sale.

BREW PUB. A brewer who also holds one or more retail on-sale licenses and who manufactures fewer than 3,500 barrels of malt liquor in a year, at any one licensed premises, the entire production of which is solely for consumption on tap on any licensed premises owned by the brewer, or for off-sale from those licensed premises as permitted in Minn. Stat. § 340A.24, subd. 2.

BREWER TAPROOM. A facility on the premises of or adjacent to the premises owned by a brewer, licensed under Minn. Stat. § 340A.301, subd. 6, (c), (i) or (j), intended for the on-sale consumption and limited off sale of beer produced on site by the brewer as authorized by Minn. Stat. § 340A.26.

Section 2. Ordinance No. 157 of the Owatonna Zoning Ordinance is hereby amended by amending Section 157.021 in its entirety and amend to read as follows with strikethroughs being deleted and underlines being additions:

Section 3. Ordinance No. 157 of the Owatonna Zoning Ordinance is hereby amended by amending Section 157.022 in its entirety and amend to read as follows with strikethroughs being deleted and underlines being additions:

Brewer Taproom	P	P



- (17) Brewery
- (18) Brew Pub
- (19) Brewer Taproom
