SUBJECT: Off-Site Gambling Request

PURPOSE:

Council to approve Resolution 49-21 approving applications received from Owatonna Youth Hockey to Conduct Off-Site Gambling.

BACKGROUND:

Owatonna Youth Hockey requests authorization to offer pull-tabs and bingo during the Rustic Mama's Market events this summer. They have obtained Vendor Agreements to participate in these events planned for the last weekends of June and July 2021 at Ye Ole Beer Garden/Fair Square on the Steele County Fairgrounds. Completed applications and copy of their Vendor Agreements were received for each weekend.

BUDGET IMPACT:

None, the City receives an annual fee from organizations conducting lawful gambling within in the City and no additional fee for these organizations to Conduct Off-Site Gambling.

STAFF RECOMMENDATION:

Staff recommends Council approve Resolution 49-21.

RESOLUTION NO. 49-21

A RESOLUTION APPROVING
APPLICATION TO CONDUCT OFF-SITE GAMBLING

WHEREAS, the Owatonna Youth Hockey is licensed and authorized to conduct Lawful Charitable Gambling in the City of Owatonna at sites which they hold approved premises permit; and

WHEREAS, Minnesota Statute 349, Subd.5, Off-site Permits, allows a licensed organization to conduct lawful gambling on a premises other than the organization's permitted premises if it has first submitted to the board an application and a lease on forms provided by the board, obtained authorization required under section 349.213 and received a permit from the board for each event up to 12 events in a calendar year, not to exceed three days per event; and

WHEREAS, The Rustic Mama's Market will be held in Ye Ole Beer Garden/Fair Square on the Steele County Fairgrounds during two weekends the Summer of 2021:

Saturday, June 26 – Sunday, June 27

Saturday, July 31 – Sunday, August 1

and

WHEREAS, Owatonna Youth Hockey has made application to conduct lawful gambling Off-Site at these two events.

NOW THEREFORE, BE IT RESOLVED by the City Council of the City of Owatonna, Minnesota, the application to conduct Off-Site Gambling for these dates and location as submitted by the Owatonna Youth Hockey may be and hereby is approved.
