SUBJECT: Annual Renewal Liquor Licenses

Purpose:

Council approval to renew annual Liquor Licenses.

Background:

Liquor Licenses expire June 30th each year. This is a request to authorize renewal of licenses shown on the attached list, contingent on receipt of all required items. Each year, we receive applications, proof of insurance for worker's compensation and liquor liability, consent to background investigation and payment of fees.

Budget Impact:

Fees vary per type of license; our current annual fees include:

On-Sale Liquor License - \$3,000

Off-Sale Liquor License - \$200

Club On-Sale Liquor License – Fees vary based on number of club memberships,
current amounts vary between \$500 and \$800.

On-Sale Beer License - \$100

On-Sale Wine License - \$150

Sunday Sales for On-Sale Liquor Permit - \$200
