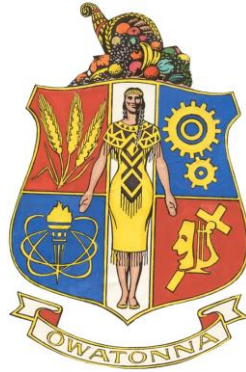

SUBJECT: Winter Parking

Purpose:

City Council approve first reading of Proposed Ordinance 21-1 to modify City Code 72.02, Parking During Street Maintenance or Snow Emergency pertaining to winter parking during street maintenance or snow emergency.

Background:

The ordinance currently calls for signs to be placed at the entrances to the community with information on winter parking restrictions and a hotline number that can be called for more information. The Police Department has developed a winter parking app which provides a better source of information. Although signs will not be required, in response to council concerns over notification, signs will be placed all major entrances to the city. Additionally, the hotline was no longer maintained.

AN ORDINANCE AMENDING CHAPTER 72.05 PARKING DURING STREET MAINTENANCE OR SNOW EMERGENCY OF THE 2015 ORDINANCE CODE OF THE CITY OF OWATONNA, ENTITLED "PARKING RULES GENERALLY" BY AMENDING CHAPTER 72.05 PARKING DURING STREET MAINTENANCE OR SNOW EMERGENCY"

NOW THEREFORE, THE CITY COUNCIL OF THE CITY OF OWATONNA, MINNESOTA, DO ORDAIN:

Section 1. Chapter 72 of the 2015 Ordinance Code of the City of Owatonna, entitled "Parking Rules Generally", Chapter 72, 72.05 Parking During Street Maintenance or Snow Emergency:

~~(B) Signs announcing the existence of the winter parking ordinance and the hotline telephone number shall be placed at all entrances to the city.~~

(B)(C)—No vehicle shall be parked or be permitted to remain on any street in or serving the Business District, as defined in § [71.065](#) of this code of ordinances, between the hours of 2:00 a.m. and 5:00 a.m. on any day, contrary to the signs ordered by the Council to be posted on such streets. Signs in place effective upon the adoption of this chapter shall be in effect until ordered changed.

(C)(D)—Any violation of this section shall be subject to the penalties set forth in § [71.999](#) of this chapter

Section 2. Effective date. This Ordinance shall be in full force and effect from and after its passage and publication.
