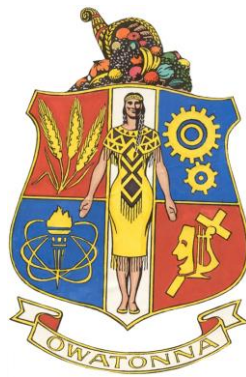

SUBJECT: 2020 Crack Sealing and Sealcoating Project, Project .No. 20013

Purpose:

Requesting City Council approval of Resolution 33-20: 2020 Crack Sealing and Sealcoating Project Bid Acceptance and Contract Awarding. Approximately 6.25 miles are planned for crack sealing and sealcoating in 2020.

Background:

Bids were received on March 11, 2020 for the 2020 Crack Sealing and Sealcoating Project. Bids were received from four (4) companies:

Pearson Bros, Inc of Hanover, MN	\$156,924.80
Allied Blacktop Company	\$208,958.00
Asphalt Surface Technologies Corporation of St. Cloud, MN	\$213,175.60
Fahrner Asphalt Sealers, LLC of Eau Claire, WI	\$244,871.52
Engineer's Estimate:	\$226,470.00

The lowest responsible bidder was Pearson Bros, Inc of Hanover, MN. The base bid was \$69,545.20 or 30.7% under the Engineer's Estimate.

Budget Impact:

\$156,924.80 construction costs will be paid from the Operating Budget.

Staff Recommendation:

Staff recommends approval of Resolution 33-20 Approving Bids and Awarding the Contract to Pearson Bros. Inc.

RESOLUTION NO. 33-20

A RESOLUTION ACCEPTING BID AND AWARDING CONTRACT

WHEREAS, pursuant to an Advertisement for Bids for the 2020 Crack Sealing and Sealcoating Project bids were received from four (4) companies. The following bids were received:

WHEREAS, the lowest responsible bidder was Pearson Bros, Inc of Hanover, MN

NOW THEREFORE, BE IT RESOLVED by the City Council of the City of Owatonna, Minnesota, as follows:

1. The Mayor and Clerk are hereby authorized and directed to enter into a contract with Pearson Bros, Inc in the name of the City of Owatonna for the 2020 Crack Sealing and Sealcoating Project according to the plans and specifications therefore approved by the City Council and on file in the office of the City Clerk.

2. The City Clerk is hereby authorized and directed to return forthwith to all bidders the deposits made with their bids, except that the deposits of the successful bidder and the next lowest bidder shall be retained until a contract has been signed.
